This Contract made and entered into this 24th day of July 2023, in General Santos City, Philippines, by and between:


 **PHILIPPINE PORTS AUTHORITY (PPA), PORT MANAGEMENT OFFICE (PMO)-SOCSARGEN**, a government instrumentality with principal office at Makar Wharf, Barangay Labangal, General Santos City, represented by its Port Manager **CESAR M. DATAYA**, herein referred to as the **ENTITY**.

- and -

 **ONE ALPHA NETWORK OPC**, a duly registered One Person Corporation and existing in accordance with Philippine laws, with office address at Alzona Compound, Purok Malinawon, Mabuhay Road, Barangay Mabuhay, General Santos City represented herein by its duly authorized representative, **SHEENA MAE SIAO DELES**, as evidenced by Special Power of Attorney dated June 6, 2023 hereto attached as Annex "A", herein referred to as the **CONTRACTOR**.

**ANTECEDENTS:**

 In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its Bulletin Board, an Invitation to Re-Bid for the Procurement of Information and Communication Technology Equipment for PMO SOCSARGEN for CY 2023 with an Approved Budget for the Contract (ABC) of Two Million One Hundred Three Thousand Pesos (Php2,103,000.00), inclusive of twelve percent (12%) VAT;

 In response to the said advertisement, only two (2) bidders submitted bid for the foregoing project;

set forth in its proposal was found to be the Lowest Calculated Responsive Bid in the amount of **TWO MILLION SEVENTY ONE THOUSAND PESOS (Php2,071,000.00)**, inclusive of twelve percent (12%) VAT, Philippine Currency;

Pursuant to Resolution No. 019 Series of 2023, award of contract was made to CONTRACTOR in a Notice of Award dated July 5, 2023, in the amount of **TWO MILLION SEVENTY ONE THOUSAND PESOS (Php2,071,000.00)**, inclusive of twelve percent (12%) VAT, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;

CONTRACTOR, duly accepted the award by signing its Conforme on the said Notice of Award on July 20, 2023;

NOW, THEREFORE, the parties agree as follows:






