NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC), hereby RESOLVED as it is hereby RESOLVED:

- a. To declare R.M. PAJIMNA BUILDERS as the Bidder with the Lowest Calculated Responsive Bid (LCRB) for the project REPAIR/IMPROVEMENT OF GATE AND FENCE AT TMO-PASIG ALONG MUELLE DEL RIO ST. AND CLOVER LEAF AT 2ND ST.
- b. To award the Contract to R.M. PAJIMNA BUILDERS as the bidder with the Lowest Calculated Responsive Bid (LCRB) in the amount of Four Million Eight Hundred Fifty Seven Thousand Three Hundred Sixteen Pesos and 76/100 (P4,857,316.76), subject to existing rules and regulations.
