

1. Contractor's All Risk Insurance (CARI) form GSIS or a private insurance company duly accredited by the Insurance Commission;
2. Performance Security in the amount of ten percent (10%) of the total bid price for cashier/manager's check or thirty percent (30%) of the total bid price for surety bond;
3. Construction Schedule and S-Curve;
4. Manpower Schedule;
5. Construction Methods;
6. Equipment Utilization Schedule;
7. Construction Safety and Health Program received by the Department of Labor and Employment, and
8. PERT/CPM


Failure to enter into said contract or provide the Performance Security/Bond and other documentary requirements stated above shall constitute sufficient ground for cancellation of this Award and forfeiture of your Bid Security.

Please be reminded to submit in writing to us personally or send by registered mail or thru your email your confirmation of receipt of this Notice of Award with two (2) calendar days upon receipt hereof.
