TERMS OF REFERENCE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF Good Governance and Phronetic Leadership

1. BACKGROUND

The Human Resource Management Department, in fulfillment of its commitment in implementing the Management Succession Program will conduct the Good Governance and Pronetic Leadership Training for Leadership pipeline.

The primary goal of this program is to effectively equip, develop, and enable leaders to effectively and efficiently improve organizational performance using new methodologies that should introduce innovation in their processes and culture.

To support the program, and to alleviate the need of participants to look for a place to eat during major breaks, it is necessary to have a good and reliable catering service that will provide meals. This defrays our difficulty in meals preparation and distribution

2. SCOPE OF WORK

2.1 Duration

2.2 Scope of Services

- 2.2.1 The serving type is managed buffet;
- 2.2.2 Quality of food and drinks for fifty (50) pax must be ensured;
- 2.2.3 Menu consists of five (5) viands of meat (beef, pork, chicken and fish), side dish (soup and veggies), appetizer, dessert or fruits in season, rice, water and juice.

2.3 Provision of the following:

- 2.3.1 Adequate staff to set-up the food, utensils and tables;
- 2.3.2 Plates, glasses, spoons, forks and cutleries to be used during the activity;
- 2.3.3 Chairs with seat covers and round tables with flower centerpieces
- 2.3.4 Trained waiters for distribution of food and drinks
- 2.4 Ingress time is at least an hour before the program.

3. REQUIREMENTS

4. PAYMENT

5. BUDGET ALLOCATION

The budget estimates for the procurement of catering services for the Good Governance and Phronetic Leadership amounted to FOUR HUNDRED THOUSAND PESOS ONLY (P400,000.00), inclusive of VAT.
