



REQUEST FOR QUOTATION (RFQ)

1. The Philippine Ports Authority, Port Management Office of Batangas (PPA-PMOB) through its Bids and Awards Committee (PMOB-BAC), will undertake procurement of **“Hauling and Disposal of Generated Hazardous Wastes at the PMO Batangas”** through Small Value Procurement (SVP) in accordance with Section 53.9 of the Revised Implementing Rules and Regulations of Republic Act No. 9184. The details of the project are the following:
