- All quotations shall be inclusive of the applicable Value Added Tax (VAT) and shall be valid for a period of ninety (90) calendar days from the deadline of submission of quotations
- Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by the signatory or his/her duly authorized representative/s.
- Liquidated damages equivalent to one tenth (1/10) of one percent (1%) of the value of Purchase Order not completed within the prescribed completion period shall be imposed per day to day of delay of the undelivered item/s. The PPA may rescind the agreement once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of purchase order, without prejudice to other courses of action and remedies open to it.
- Any or all of the items for the project shall be awarded to the bidder determined to be the Single or Lowest Calculated and Responsive Quotation.
- In order to assure that manufacturing defects shall be corrected by the winning bidder, a warranty security shall be required from the winning bidder for a minimum period of one (1) year, after acceptance by PPA representative of the delivered item/s. The obligation for the warranty shall be covered by either retention money in an amount equivalent to at least one percent (1%) of total amount of purchase order, or a special bank guarantee equivalent to at least one percent (1%) of the total amount of purchase order. The said amounts shall only be released after the lapse of the warranty period. Provided, however, that the item/s delivered are free from patent and latent defects and all the conditions imposed under this RFQ have been fully met.
- PPA-PMOB reserves the right to reject any and all bids, declare a failure of bidding, or not award the Contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
