



**INVITATION FOR SUBMISSION OF QUOTATION
(SMALL VALUE PROCUREMENT)**

The Philippine Ports Authority, Port Management Office of Bohol through its Bids and Awards Committee (BAC), invites interested contractors/bidders for the herein project:
"PREVENTIVE MAINTENANCE AND REPAINTING OF EXISTING MOORING AND FENDERING SYSTEMS AT THE PORTS OF TAGBILARAN, TUBIGON, UBAY, JAGNA, TALIBON, GETAFE, TAPAL, AND LOON".

Approved Budget for the Contract (ABC) : Php 958,012.15

Scope of Work :

1. Preventive maintenance and repainting of existing mooring and fendering system, concrete curbs, cleaning, de-rusting, tightening of nuts and bolts of V-type Fenders, numbering of mooring bollards and fenders, ***Port of Tagbilaran***
2. Preventive maintenance and repainting of existing mooring and fendering system, to incl. concrete curbs, cleaning, de-rusting, tightening of fender bolts, numbering of mooring bollards and fenders, ***Port of Tubigon***
3. Preventive maintenance and repainting of existing mooring and fendering system, concrete curbs, cleaning, de-rusting, numbering of mooring bollards and fenders, ***Port of Ubay***
4. Preventive maintenance and repainting of existing mooring and fendering system to incl. concrete curbs, cleaning, de-rusting, tightening of fender bolts, numbering of mooring bollards and fenders bollards and fenders, ***Port of Jagna***
5. Preventive maintenance and repainting of existing mooring and fendering system to incl. concrete curbs, cleaning, de-rusting, tightening of fender bolts, numbering of mooring bollards and fenders bollards and fenders, ***Port of Talibon***
6. Preventive maintenance and repainting of existing mooring and fendering system to incl. concrete curbs, cleaning, de-rusting, tightening of fender bolts, numbering of mooring bollards and fenders, ***Port of Getafe***



7. Preventive maintenance and repainting of existing mooring and fendering system, concrete curbs, cleaning, de-rusting, tightening of bolts and nuts, numbering of mooring bollards and fenders, **Port of Tapal**
8. Preventive maintenance and repainting of existing mooring and fendering system, concrete curbs incl. cleaning, de-rusting, tightening of fender bolts and repainting and numbering of mooring bollard and fenders, **Port of Loon**

Prospective bidders shall submit their quotations, together with the Certified True Copies of the following documents in three (3) sets, one (1) original and two (2) duplicate copies:

1. Valid Mayor's Business Permit
2. PhilGEPS Registration Number
3. Omnibus Sworn Statement
4. Income/Business Tax Return
5. PCAB License - Small A (Ports, Harbor and Offshore Engineering)

A complete set of documents may be purchased by interested bidders from the address given below and upon payment of a **non-refundable** fee for the bidding documents in the amount of **ONE THOUSAND PESOS ONLY (P=1,000.00)** as per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

Procurement will be conducted in consonance with Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Only sealed quotations/canvass from eligible bidders will be opened and contract will only be awarded to the **Lowest Calculated and Responsive Bidder** who will be determined during the conduct of the post-qualification.

The PPA, PMO-Bohol will hold a **Pre-Bidding Conference on 18 October 2019, 2:00 PM at the Multi-Purpose Hall, PPA PMO-Bohol Administration Building, Port Area, Tagbilaran City, Bohol.**

Quotations must be submitted to the address given below on or before **10:00 AM of Thursday, 31 October 2019** to the Secretariat, Bids and Awards Committee (BAC). Said quotations will be opened on the same day at **10:30 AM.**

The Philippine Ports Authority, PMO – Bohol reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award; without thereby incurring any liability to the affected Bidder/s.


