



**INVITATION FOR SUBMISSION OF QUOTATION
(SMALL VALUE PROCUREMENT)**

The Philippine Ports Authority, Port Management Office of Bohol through its Bids and Awards Committee (BAC), invites interested contractors/bidders for the herein project: **“REPAIR OF TMO BUILDING, SECURITY FENCE AND GATES, PORT OF TAPAL, TAPAL, UBAY, BOHOL”**

Approved Budget for the Contract (ABC) : Php 707,727.07

Scope of Work :

Repair of TMO Building

1. Repair of damaged ceiling to include accessories and removal of existing damaged marine plywood ceiling;
2. Repair of damaged electrical fixtures to include electrical wires and its accessories;
3. Repair of wooden cabinet to include its accessories;
4. Painting of Fiber Cement Board ceiling and wooden cabinets to include repainting of existing concrete wall and wooden doors and jambs of TMO Building;
5. Repair of damaged roofing and gutter to include its accessories and removal of existing damaged gutter and roofing;
6. Repair of elevated water tank and cistern tank; and
7. Repair of damaged built-up acrylic signages and logo to include repainting of existing signages.

Repainting of Security Fence and Gate

1. Repainting of existing security fence and painting of newly completed security fence; and
2. Repair of existing damaged security gate.

Prospective bidders shall submit their quotations, together with the Certified True Copies of the following documents in three (3) sets, one (1) original and two (2) duplicate copies:

1. Valid Mayor's Business Permit ;
2. PhilGEPS Registration Number;
3. Omnibus Sworn Statement;
4. Income/Business Tax Return; and
5. PCAB License (Small A).

A complete set of documents may be purchased by interested bidders from the address given below and upon payment of a **non-refundable** fee for the bidding documents in the amount of **ONE THOUSAND PESOS ONLY (Php 1,000.00)** as per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.



Procurement will be conducted in consonance with Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Only sealed quotations/canvass from eligible bidders will be opened and contract will only be awarded to the **Lowest Calculated and Responsive Bidder** who will be determined during the conduct of the post-qualification.

Quotations must be submitted to the address given below on or before **10:00 AM of Wednesday, October 25, 2023** to the Secretariat, Bids and Awards Committee (BAC). Said quotations will be opened on the same day at **10:30 AM**.

The Philippine Ports Authority, PMO-Bohol reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award; without thereby incurring any liability to the affected Bidder/s.
