

## INVITATION FOR SUBMISSION OF QUOTATION

(SMALL VALUE PROCUREMENT)

The Philippine Ports Authority, Port Management Office of Bohol through its Bids and Awards Committee (BAC), invites interested contractors/bidders for the herein project: "REPAINTING/MAINTENANCE OF COVERED WALKWAY, SECURITY FENCE AND GATES TO INCLUDE REPAIR OF PASSENGER TERMINAL BUILDING, PORT OF LOON, CATAGBACAN, LOON, BOHOL"

Approved Budget for the Contract (ABC): Php 493,071.53

## Scope of Work:

Repainting of Security Fence and Gates

- 1. Repainting of security fence to include derusting;
- 2. Repainting of existing security gate to include welding works on minor damages; and
- 3. Repainting of covered walkway to include installation of fascia cover.

## Repair of Passenger Terminal Building

- Repair of exterior ceiling at Passenger Terminal Building to include removal of existing ceiling debris;
- Repair of damaged electrical fixtures to include electrical wires and its accessories;
- 3. Repair of damaged logo and signages to include repainting;
- Plastering of CHB wall above the ceiling line to bottom of the beam to include removal and reinstallation of affected ceiling panel and waterproofing; and
- Repainting of Passenger Terminal Building exterior wall to include repair of cracks on wall

Prospective bidders shall submit their quotations, together with the Certified True Copies of the following documents in three (3) sets, one (1) original and two (2) duplicate copies:

- 1. Valid Mayor's Business Permit;
- 2. PhilGEPS Registration Number;
- 3. Omnibus Sworn Statement;
- 4. Income/Business Tax Return; and
- 5. PCAB License (Small A).

A complete set of documents may be purchased by interested bidders from the address given below and upon payment of a **non-refundable** fee for the bidding documents in the amount of **FIVE HUNDRED PESOS ONLY (Php 500.00)** as per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.



Procurement will be conducted in consonance with Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Only sealed quotations/canvass from eligible bidders will be opened and contract will only be awarded to the **Lowest Calculated and Responsive Bidder** who will be determined during the conduct of the post-qualification.

Quotations must be submitted to the address given below on or before 10:00 AM of Wednesday, October 25, 2023 to the Secretariat, Bids and Awards Committee (BAC). Said quotations will be opened on the same day at 10:30 AM.
