



**INVITATION FOR SUBMISSION OF QUOTATION  
(SMALL VALUE PROCUREMENT)**

The Philippine Ports Authority, Port Management Office of Bohol through its Bids and Awards Committee (BAC), invites interested contractors/bidders for the herein project:  
**“REPAIR OF DAMAGED TMO-BUILDING, QUARTERS AND STORAGE ROOM,  
PORT OF TALIBON, TALIBON, BOHOL”**

***Approved Budget for the Contract (ABC) : Php 987,586.52***

**Scope of Work :**

*Repair of TMO Building*

1. Repair of damaged longspan roofing, gutter and PVC downspout to include removal works;
2. Repair of ceiling to include removal of existing damaged ceiling;
3. Repair of wooden kitchen cabinet to include its accessories;
4. Painting of fiber cement board ceiling and wooden cabinets to include repainting of existing concrete walls, wooden partitions, parapets, wooden doors and jambs;
5. Repair of electrical fixtures to include electrical wires and its accessories;
6. Repair of aluminum sliding windows and wooden doors of various sizes to include its accessories; and
7. Repair of waiting area canopy shed.

*Repair of Quarters and Storage Room*

1. Repair of damaged roofing, gutter and PVC downspout to include repainting of existing steel trusses and c-purlins;
2. Repair of ceiling and partition walls to include removal of existing damaged wooden ceiling and partition walls;
3. Repair of electrical fixtures to include electrical wires and its accessories;
4. Repair of damaged doors and windows of various types and sizes;
5. Repainting of interior and exterior walls and ceiling to include wooden doors and jambs; and
6. Declogging/siphoning of existing septic vault.

Prospective bidders shall submit their quotations, together with the Certified True Copies of the following documents in three (3) sets, one (1) original and two (2) duplicate copies:

1. Valid Mayor's Business Permit ;
2. PhilGEPS Registration Number;
3. Omnibus Sworn Statement;
4. Income/Business Tax Return; and
5. PCAB License (Small A).



A complete set of documents may be purchased by interested bidders from the address given below and upon payment of a **non-refundable** fee for the bidding documents in the amount of **ONE THOUSAND PESOS ONLY (Php 1,000.00)** as per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

Procurement will be conducted in consonance with Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Only sealed quotations/canvass from eligible bidders will be opened and contract will only be awarded to the **Lowest Calculated and Responsive Bidder** who will be determined during the conduct of the post-qualification.

Quotations must be submitted to the address given below on or before **10:00 AM of Wednesday, October 25, 2023** to the Secretariat, Bids and Awards Committee (BAC). Said quotations will be opened on the same day at **10:30 AM**.




