



## INVITATION FOR SUBMISSION OF QUOTATION (SMALL VALUE PROCUREMENT)

The Philippine Ports Authority, Port Management Office of Bohol through its Bids and Awards Committee (BAC), invites interested contractors/bidders for the herein project: **'REPAIR OF MESS HALL AT THE BACK OF THE NEWLY REPAIRED PASSENGER TERMINAL BUILDING, PORT OF JAGNA, BOHOL'**.

***Approved Budget for the Contract (ABC) : Php 676,125.09***

### **Scope of Work :**

1. Supply and place, 3500psi concrete for pedestal/foundation and concrete overlay to include steel reinforcements, formworks, chipping, and drilling of PCCP;
2. Supply, fabricate and install steel framing for columns, trusses, purlins and its accessories to include painting;
3. Supply and install pre-painted longspan color roof to include accessories, skylight, aluminum insulator and downspout;
4. Supply and install various sizes of unglazed ceramic floor tiles; and
5. Supply, deliver and install electric wires, cables and conduit pipes of various sizes and accessories.

Prospective bidders shall submit their quotations, together with the Certified True Copies of the following documents in three (3) sets, one (1) original and two (2) duplicate copies:

1. Valid Mayor's Business Permit
2. PhilGEPS Registration Number
3. Omnibus Sworn Statement
4. Income/Business Tax Return
5. PCAB License - Small A (Building and Industrial Plant)

A complete set of documents may be purchased by interested bidders from the address given below and upon payment of a **non-refundable** fee for the bidding documents in the amount of **ONE THOUSAND PESOS ONLY (Php 1,000.00)** as per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

Procurement will be conducted in consonance with Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Only sealed quotations/canvass from eligible bidders will be opened and contract will only be awarded to the **Lowest Calculated and Responsive Bidder** who will be determined during the conduct of the post-qualification.
