

 - b. PhilGEPS Registration Number;
 - c. Certified True Copy of PCAB License; **SMALL B - BUILDINGS License**
 - d. Certified True Copy of Latest Income and Business Tax Returns for CY 2016;
 - e. Omnibus Sworn Statement (**PRO-FORMA ATTACHED**);
 - f. Certified True Copy of Barangay Certification for CY 2017 issued Barangay Office where the principal office is located;
 - g. List of Contractors Key Personnel;
 - h. Manpower Utilization Schedule.
4. A Performance Security in the amount and form as prescribed under Section 39.2 of Revised IRR of RA 9184 must be submitted within five (5) days after the receipt of PO.
