



## REQUEST FOR QUOTATION (RFQ)

The Philippine Port Authority, PMO-Zamboanga del Norte, through its Bids and Awards Committee will undertake Negotiated Procurement – Sec.53.9. Small Value Procurement for the **Provision of 3 Units Current Transformer and 3 Units Potential Transformer at Meter Entrance, Repair of Waterline and Repair of Pavement Beside the CHB Fence and TMO Building, Port of Sindangan, Zamboanga Del Norte** in accordance with Section 53.9 of the Implementing Rules and Regulation of Republic Act No. 9184.

Interested bidders are required to submit their **valid and current Mayor's Permit, Phil-GEPS Registration Number, PCAB License, Income/Business Tax Income Return and Omnibus Sworn Statement** unless the same were already submitted prior to this procurement. For methods of procurement requiring Mayor's Permits & Phil-GEPS Registration, Certificate of Platinum Memberships may be submitted in lieu of the said documents. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

Only sealed Quotation from eligible bidders will be opened and a contract will only be awarded to the Lowest Calculated Responsive Bidder who was determined as such during post-qualification. Quotation submitted thru e-mail shall not be accepted. Further, if quotation is submitted personally, bidder must submit a SPA or Secretary's Certificate, whichever is applicable, otherwise the same will not be accepted.

Opening of quotation shall be on **November 15, 2019, Friday, 2:00 P.M.** at the PPA Conference Room, PMO-Zamboanga del Norte, Port Area, Dapitan City.

The PPA, PMO-Zamboanga del Norte reserve the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder of bidders.
