Interested bidders are required to submit their **valid and current Mayor's Permit, Phil-GEPS Registration Number, PCAB License (Small B-Building and Industrial Plant), Income/Business Tax Income Return and Omnibus Sworn Statement** unless the same were already submitted prior to this procurement. For methods of procurement requiring Mayor's Permits & Phil-GEPS Registration, Certificate of Platinum Memberships may be submitted in lieu of the said documents. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

Only sealed Quotation from eligible bidders will be opened and a contract will only be awarded in favor to the Contractor with the Single or Lowest Calculated Responsive Quotation who was determined and evaluated as such during its opening. Quotation submitted thru e-mail shall not be accepted. Further, if quotation is submitted personally, bidder must submit a SPA or Secretary's Certificate, whichever is applicable, otherwise the same will not be accepted.

The winning bidder shall be required to post a performance security prior to the signing of contract in accordance with Sec. 39 of the 2016 IRR of RA 9184. The same shall be posted and shall be released after the issuance of the Certificate of Final Acceptance.

Opening of quotation shall be on **November 13, 2023, 2PM** at the PPA Conference Room, PMO-Zamboanga del Norte, Port Area, Dapitan City.
