Invitation to Bid for the *Repair of Damaged RoRo Ramp and Retaining Wall, Transit Shed, PMO Building, Security Fence and Covered Parking Area damaged by Typhoon “Ursula” Port of Tacloban, Tacloban City*

1. The *Philippine Ports Authority, Port Management Office of Eastern Leyte/Samar (PMO-EL/S)*, through the *Corporate Funds 2021* intends to apply the sum of **Ten Million Six Hundred Fifty Nine Thousand Three Hundred Seventy Eight Pesos and 0/100 (Php. 10,659,378.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***Repair of Damaged RoRo Ramp and Retaining Wall, Transit Shed, PMO Building, Security Fence and Covered Parking Area damaged by Typhoon “Ursula”, Port of Tacloban, Tacloban City, NRP-ELS-01-21.*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Ports Authority, PMO-EL/S* now invites bids for the above Procurement Project. Completion of the Works is required *One Hundred Eighty (180) Calendar Days*. Bidders should have completed a contract similar to the Project which involves Port Construction/Repair Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). Required PCAB Registration is Small B – Ports & Harbor & Offshore Engineering.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the *Philippine Ports Authority, PMO-EL/S Bids and Award Committee (BAC) Secretariat* and inspect the Bidding Documents at the address given below from *Monday to Friday, 8:00 A.M. to 5:00 P.M.*
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 7, 2022** from given address and website/s below and *upon payment of a non refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php. 25,000.00.* The Procuring Entity shall allow the bidder to present its proof of payment for the fees *personally by the prospective Bidder himself or herself, or through his/her authorized representative upon presentation of Special Power Attorney.*
6. The *Philippine Ports Authority, PMO-EL/S* will hold a Pre-Bid Conference on **January 17, 2022, 10:00 A.M.** at *Philippine Ports Authority, Port Management Office (PMO) – Eastern Leyte/Samar, Conference Room, 2F Admin. Building, Port Area, Tacloban City*, which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

7. Bids must be duly received by the *BAC Secretariat* through manual submission at the office address as indicated below, on or before **January 31, 2022, 9:30 A.M.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **January 31, 2022, 10:00 A.M.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Philippine Ports Authority* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
