5. Criteria for Award

The minimum concession fee for the fifteen (15) year PTMC at the Port of Ormoc is set at EIGHT HUNDRED FORTY-NINE MILLION SIX HUNDRED FORTY-SEVEN THOUSAND NINE HUNDRED SEVENTY-NINE AND 17/100 (Php 849,647,979.17).

The minimum concession fee for Year I of PTMC is THIRTY-NINE MILLION THREE HUNDRED SEVENTY-FOUR THOUSAND SIX HUNDRED THIRTY-ONE PESOS AND 02/100 (Php39,374,631.02).
